Existing Control Measures	<ol> <li>All staff to have read the Loading and Unloading Trailers document which can be found on the company's Intranet.</li> <li>Before entering the trailer ensure the ramp is flat, level and secure and square to the building.</li> <li>Never overload vehicles. Overloading them causes them to become unstable, hard to steer and less able to brake.</li> <li>Never load or unload a vehicle without checking the floor of the loading area is safe. Look for debris, broken boarding, etc and clear it if you see any.</li> <li>The loading and unloading area should be free of overhead pipes, cables and any other potential obstructions;</li> <li>Drivers are to report to Site Manager and sign in on arrival at site.</li> <li>Make sure any adhesive tubs, screed/primer bottles have the lids fitted correctly to prevent any spillages.</li> <li>Ask for help from regional staff with loading and unloading.</li> </ol>

Existing Control Measures	<ol> <li>Ensure floor has stable footing and free from exiting the trailer .</li> <li>Ensure brakes are on and loading bay ramps are attached securely.</li> <li>Make sure the vehicle floor is dry to avoid slips.</li> </ol>

Existing Control Measures	1. Area to be free from general waste to avoid tripping 2.When loading waste material on or off the vehicle, Level 5 Cut Gloves must be worn at all times
